The probationary period is 90 days, and may be increased or re-instated by Edmonton Recreational Vehicle Service Ltd. at any time. Credit card information will be stored securely on file in your account. Following the probationary period, Edmonton Recreational Vehicle Service Ltd. reserves the right to bill any overdue balances to the provided credit card.
